### TUNDRA FIRST WITH NORDIC SWAN ECOLABEL

**Tundra Sustainable Frontier Fund is among the first twelve investment funds globally to be awarded the Nordic Swan Ecolabel. Tundra Sustainable Frontier Fund, which invests in new emerging markets such as Vietnam, Sri Lanka and Nigeria, was awarded the Ecolabel by the Swedish Minister of Financial Markets and Consumer Affairs Per Bolund at an award ceremony on Tuesday afternoon.**

For the first time in Nordic Swan Ecolabel's 30-year history the ecolabel was awarded to investment funds, Tundra Sustainable Frontier Fund was one of the recipients. The Nordic Swan Ecolabel, a cooperation created by the Nordic Council of ministers, is only awarded to funds with an established record of and a systematic approach to sustainability in their investment process. Tundra Sustainable Frontier Fund, an actively managed equity fund invests globally in the new emerging markets, demonstrates these attributes.

-With 800 million people in Tundra's core markets, 1.5 times the EU population, entering the global middle class and adopting its consumer patterns, a sustainable growth path in these countries is a necessity for us all, says Tundra's CEO Jon Scheiber.

Tundra Fonder, a Swedish asset manager, specialises in investments in sustainable growth in developing economies. Tundra Sustainable Frontier Fund was launched in 2015 with seeding capital from three Swedish public institutions. Today, the asset manager carries out sustainability research from Stockholm as well as local research offices in Asia. Its sustainable investment approach is implemented across all funds.

-The Nordic Swan Ecolabel is an important complement to the new regulation the Government recently decided on which means that all investment funds will have to disclose how they implement sustainability. For investors, it should be simple to make the right choice. Sustainable funds are a smart choice for our planet as well as our wallet, says Per Bolund, Swedish Minister of Financial Markets and Consumer Affairs.
